



**Focus on Education:
Creating Engagement
1 credit hour**

Course Description

Participants in this course will examine a student-centered classroom. Topics include creating an environment rich with collaborative and engaged learning.

Course Prerequisites

Participants must hold a baccalaureate degree.

System Requirements

- Internet access connection
- Online video viewing capabilities
- Software capable of reading PDF files

Text Books/Supplemental Reading

There is no textbook required for this course. Refer to the reading assignments and supplemental resources within each Milestone to support course content.

Global Goals of the Course

1. To examine areas of best practice in instructional delivery (InTASC 3,5,8,10)
2. To develop an understanding of the need for collaborative and engaged learning in today's classroom. (InTASC 3,5,8,10)
3. To analyze current instructional practices in order to infuse more collaborative and engaged practices to better support student learning. (InTASC 3,5,7,8,10)
4. To explore possible applications for student-centered instruction in the classroom. (InTASC 1,2,3,7,8,10)
5. To synthesize best practice research and classroom applications. (InTASC 4,5,8)

Compliance with Interstate Teacher Assessment and Support Consortium (InTASC) Standards

The Interstate Teacher Assessment and Support Consortium's work is guided by one basic premise: An effective teacher must be able to integrate content knowledge with the specific strengths and needs of students to assure that all students learn and perform at high levels. All teachers should meet the following standards: (1) learner development, (2) learning differences, (3) learning environments, (4) content knowledge, (5) application of

content, (6) assessment, (7) planning for instruction, (8) instructional strategies, (9) professional learning and ethical practices, and (10) leadership and collaboration.

Teaching Methodology and Delivery Model

Teaching methodologies used in this course are specifically designed to maximize learning in a self-paced, online distance-learning model.

- Online methodologies include presentations, skill practice, assessment completion, and the synthesis of new knowledge and skills.
- Course content and assignments are organized into modules that participants may complete at their own pace during a 4-week span of time.
- Online assignments are facilitated using a variety of research-based instructional approaches appropriate for adult learners in an online setting, which allow teachers to acquire, practice, apply, and evaluate course content and skills.
- Class participants actively construct their own learning and make it personally relevant by acquiring and applying course knowledge/skill to their own teaching situation.

Final Projects

Throughout the course, participants will engage in both informal and formal assessments. Formative assessment of learning objectives is conducted throughout the course via milestone questions requiring participants to make sense of new knowledge and/or skills within their realm of influence.

In keeping with best instructional and assessment practices, the course also requires participants to demonstrate synthesis and application of course knowledge in an applied final project linked to the instructional objectives of this course.

Final projects are due and will be submitted to the instructor within the 4 weeks of the allotted class time. Unless the instructor states otherwise, all papers are expected to be properly formatted electronically.

Assessment of the work will not be limited to the quantity of work submitted but will carefully consider the quality and intellectual value of the work. To receive full credit for completion, all work must be completed at a level of "Proficient" or above.

Formative Assessments:

- Complete all readings and online video viewing within a 4-week time frame.
- Complete Formative Assessment Portfolio at a level of Proficient or above.
- Complete all general assignment(s) related to course objectives at a level of Proficient or above.

Summative Assessment: Compilation of three strategies you implemented or plan to implement.

1. Begin researching appropriate grade level activities that will promote student engagement in your classroom. You may consider ones that are presented within the coursework, by your colleagues, or through your own research.
2. Plan 3 activities for classroom implementation.
3. Compile the 3 strategies into a product that includes the following for each:
 - Name and reference of strategy
 - Description of the strategy
 - Explanation of how the strategy might be implemented for a specific grade level.
 - Reflection on the strategy – how did it work? What needs to be changed in order to improve it? If you are unable to implement at this time, reflect on how its implementation might change your teaching practices and student learning.

Grading

Points are assigned based on a rubric that can be further defined as follows:

Distinguished: The assessment is highly imaginative; demonstrates critical thought; is unique; shows substantial application to one's own teaching or professional position; *goes above and beyond requirements*; is creative; demonstrates both breadth and depth of knowledge of transition-related subject matter; shows individual's personality; is professional in presentation and appearance; and demonstrates considerable effort. The assessment is exceptionally completed and demonstrates clear understanding of the tasks, gives explanations, and shows how the assessment applies to a teaching/learning situation. The assessment meets the specific criteria delineated in "Distinguished" on the course rubric.

Proficient: The assessment is well-organized and complete; is effectively and clearly presented; demonstrates clear understandings; applies what has been learned to the author's own classroom situation; clearly shows connections; is detailed; and is thoughtful and supported with ideas. A thoroughly completed assessment demonstrates that the participant shows awareness of the tasks, gives explanations, and shows how the assessment applies to a teaching/learning situation. The assessment meets the specific criteria delineated in "Proficient" on the course rubric.

Basic: This is the lowest passing grade. The assessment meets minimum requirements; includes general information but lacks descriptive detail; shows limited application to teaching/learning; and lacks originality. This denotes work that does not meet **all** aspects of standards for academic performance in a graduate-level course. The assessment meets the specific criteria delineated in "Basic" on the course rubric.

Unsatisfactory: The assessment is missing evidence or information; is sloppy and poorly organized; demonstrates only surface understandings; shows no evidence of application to the author's own teaching situation; is poorly written; and does not meet minimum

standards for academic performance in a graduate-level course. The assessment meets the specific criteria delineated in “Unsatisfactory” on the course rubric.
